**Information, Rules and Day-of Instructions**

- We will email your exhibit number, information and directions the week of the event.
- **Your exhibit space MUST be set up by 7:45 a.m.** Walkers will begin arriving at 8 a.m. to register and check-in.

- You may not be able to unload near your space, depending on the location. There will be volunteers available to assist, but please be prepared to transport your items to your space. We strongly encourage you to bring a dolly for convenience of setup.
- If you have large/heavy items to unload, please enter at the Lakeland Electric Parking Garage off Orange Street; promptly unload and then move your vehicle to a designated space. If you are placing a car for display, please check-in FIRST as someone from the City of Lakeland can assist you in order to preserve the grass.
- Electrical spaces are very limited and are not guaranteed. Exhibitors must provide their own electrical cords and duct tape to secure them; 100 ft cords may be needed.
- No loud generators.
- No refunds due to weather, acts of nature or cancellation.
- You may not "sublet" your exhibit space or share your space with another organization or company.
- Spaces are 10' x 10'. SPCA Florida does not provide rental equipment. Exhibitors may bring their own 10' x 10' canopy tent. Tents larger than 10' x 10' are strictly prohibited due to fire regulations.
- You must bring your own tent anchors. **Stakes CANNOT be driven into the ground.**
- Parking is available on a first come, first serve basis in the parking lots behind the Lake Mirror Theater and auditorium on Lake Street, in the lots on Orange Street and in the downtown parking garages on E. Main Street and on Iowa Avenue. Obey all parking rules and traffic ordinances. SPCA Florida is not responsible for any parking violation fees.
- Make sure your area is clean before you leave.
- **To guarantee space at the event, all sponsorships and vendor FEES must be received by 5 p.m. on Friday, May 28, 2021.**
